NOTIFICATION

The member of the Local Library Authority of every district in West Bengal are nominated/appointed/elected under different clauses of Sub section (2) of Section 8 of the West Bengal Public Libraries Act, 1979(As amended from time to time).

Except the members under clauses (i), (ii), (iii)&(iii a) of Sub-section (2) of section 8 of the West Bengal Public Libraries Act, 1979 (As amended from time to time) who are the members of the LLA by virtue of their ex-officio status in their posts and except the members under Clauses (iv),(vi),(vii) of the aforesaid section who are elected and nominated as per provisions of the said Act, the members of other clauses of sub-section 2 of section 8 are nominated or appointed in terms of Government orders issued by Mass Education Extension and Library Services Department.

Under sub-section (3) of Section 8 of the West Bengal Public Libraries Act, 1979 (As Amended from time to time), the members, other than ex-officio members shall hold office for a period of 4 years or till the Local Library Authority is reconstituted whichever is earlier.

Now, in exercise of the power conferred by sub-section (1) & (2) of Section 8 read with sub-section (3) of Section 8 of the said Act the Governor is pleased to reconstitute the Local Library Authority, Burdwan with the following members under different clauses of sub-section (2) of section 8 of the West Bengal Public Libraries Act,1979 (As amended time to time):

2.	8/2-(ii)	The District Library Officer who shall function as ex-officio member – Secretary of the Local Library Authority.

4.	8/2-(iii-a)	The District Information Officer, Burdwan.
5.	8/2-(iv)	Two representatives of the employees of different Public Libraries to be elected from amongst themselves in the manner prescribed.
6.	8/2(v)	Following two members are nominated by Govt. from amongst councillors of the Municipalities within the district : (i) Sri Paresh Chandra Sarkar, Councillor, Burdwan Municipality, Burdwan, Ichlabad No.-4, P.O.-Sripally, Dist.- Burdwan, Pin-713103. (ii) Sri Khandekar Md. Sahidullah, Councillor, Ward No.-26, Burdwan Municipality, Goda Mahalla, P.O.- Lakudi, Dist.- Burdwan.
7.	8/2-(vi)	Two representatives of the district branch of the Bengal Library Association to be nominated by the Executive Committee of the said organization.

8.	8/2-(vii)	One person to be nominated by Sabhadhipati from amongst the members Zilla Parishad of Burdwan.
9.	8/2-(viii)	Following two persons are nominated by the Govt. from amongst the members of the Panchayat Samities in the district of Burdwan : (i) Sri Dilip Mallik, Sabhapati, Purbasthali – 1 Panchayet Samity, Vill. & P.O.- Srirampur, Dist.- Burdwan. (ii) Sri Swapan Ghosh, Saha-Sabhapati, Monteswar Panchayet Samity, Vill. & P.O.- Monteswar, Dist.- Burdwan.
10.	8/2-(ix)	Following two persons are nominated by the Govt. from amongst the members of the Managing Committees of Public Libraries: (i) Sri Anirban Das, Member, Managing Committee, District Library, Asansol, Kanyapur , Asansol, Dist.- Burdwan. (ii) Sri Narendranath Chakraborty, Member, Managing Committee, Naba Bharati Sangha Pathagar, Ukhra, P.O.- Ukhra , Dist.- Burdwan.
11.	8/2-(ix-a)	Following four persons representing the interest of education, social work, Cultural, literacy or artistic activity, or literacy or science movement are nominated by the Government in the district of Burdwan. (i) Sri Abhijit Ghatak, Educationist & Social Worker, Upper Chelidanga, Asansol- 4, Dist.- Burdwan. (ii) Sri Sankar Chandra Mondal, Cultural & Social Worker, Vill- Nachan, P.O.-Dhabani, Durgapur , Dist.- Burdwan, Pin-713205. (iii) Sri Pabitra Kumar Halder, Literary Worker, Vill. & P.O.- Palla, Dist.- Burdwan. (iv) Smt. Shyamoli Basu, Cultural & Science Movement Worker, Vill. – Balidanga, P.O.- Sri Pally, Dist.- Burdwan.
