**NOTIFICATION**

The member of the Local Library Authority of every district in West Bengal are nominated/appointed/elected under different clauses of Sub section (2) of Section 8 of the West Bengal Public Libraries Act, 1979(As amended from time to time).

Except the members under clauses (i),(ii),&(iii-a) of Sub-section (2) of section 8 of the West Bengal Public Libraries Act, 1979 (As amended from time to time) who are the members of the LLA by virtue of their ex-officio status in their posts and except the members under Clauses (iv),(vi),(vii) of the aforesaid section who are elected and nominated as per provisions of the said act, the members of other clauses of sub-section 2 of section 8 are nominated or appointed in terms of Government orders issued by Mass Education Extension and Library Services Department.

Under sub-section (3) of Section 8 of the West Bengal Public Libraries Act, 1979 (As Amended from time to time), the members, other than ex-officio members shall hold office for a period of 4 years or till the Local Library Authority is reconstituted whichever is earlier.


Now, in exercise of the power conferred by sub-section (1)& (2) of Section 8 read with sub-section (3) of Section 8 of the said act the Governor is pleased to reconstitute the Local Library Authority, South 24 Parganas with the following members under different clauses of sub-section (2) of section 8 of the West Bengal Public Libraries Act,1979 (As amended time to time):
