NOTIFICATION

In exercise of the power conferred by Sub section (1) of Section 10A of The West Bengal Public Libraries Act, 1979, since amended, the Governor is pleased to supersede the existing Local Library Authority, Darjeeling Gorkha Hill Council Area (DGHC Area), Darjeeling and to appoint an Ad-hoc Committee in terms of provisions 10(A)(2)(b) as laid down in the said Act, consisting of the following members:-

1.	The District Magistrate and Principal Secretary, DGHC Area, Darjeeling - Chairman.
2.	The Secretary, Library Services Department, DGHC Area, Darjeeling - Member.
3.	The District Library Officer, DGHC Area, Darjeeling – Member Secretary.
4.	The District Information and Cultural Officer, Darjeeling – Member.
5.	The District Mass Education Extension Officer, Darjeeling – Member.
6.	MLAs from DGHC Area, Darjeeling – Members.
7.	Three persons representing the interest of education, social work, cultural, literary or artistic activity, or literacy or science movement, to be nominated by the District Magistrate and Principal Secretary, DGHC Area, Darjeeling – Members.

The Ad-hoc Committee will exercise all the powers and perform all the duties of the Local Library Authority of the said Area, as mentioned in the said Act.

The Ad-hoc Committee so constituted will function for a period not more than one year.

This will take immediate effect.
