NOTIFICATION

The member of the Local Library Authority of every district in West Bengal are nominated/appointed/elected under different clauses of Sub section (2) of Section 8 of the West Bengal Public Libraries Act, 1979(As amended from time to time).

Except the members under clauses (i), (ii), (iii)&(iii a) of Sub-section (2) of section 8 of the West Bengal Public Libraries Act, 1979 (As amended from time to time) who are the members of the LLA by virtue of their ex-officio status in their posts and except the members under Clauses (iv),(vi),(vii) of the aforesaid section who are elected and nominated as per provisions of the said Act, the members of other clauses of sub-section 2 of section 8 are nominated or appointed in terms of Government orders issued by Mass Education Extension and Library Services Department.

Under sub-section (3) of Section 8 of the West Bengal Public Libraries Act, 1979 (As Amended from time to time), the members, other than ex-officio members shall hold office for a period of 4 years or till the Local Library Authority is reconstituted whichever is earlier.

Now, in exercise of the power conferred by sub-section (1) & (2) of Section 8 read with sub-section (3) of Section 8 of the said Act the Governor is pleased to reconstitute the Local Library Authority, Birbhum with the following members under different clauses of sub-section (2) of section 8 of the West Bengal Public Libraries Act,1979 (As amended time to time):

1.	8/2-(i)	The District Magistrate or his nominee not below the rank of Sub-Divisional Officer shall be the Chairman.
2.	8/2-(ii)	The District Library Officer who shall function as ex-officio member – secretary of the Local Library Authority.
3.	8/2-(iii)	The District Mass Education Extension Officer, Birbhum.
4.	8/2-(iii-a)	The District Information Officer, Birbhum.
5.	8/2-(iv)	Two representatives of the employees of different Public Libraries to be elected from amongst themselves in the manner prescribed.
6.	8/2(v)	Following two members are nominated by Govt. from amongst commissioners of the Municipalities within the district : (i) Sri Omar Sk. , Councillor, Bolpur Municipality, P.O.- Bolpur, Dist.- Birbhum. (ii) Sri Vidya Sagar Saw, Councillor, Suri Municipality, P.O.- Suri, Dist.- Birbhum.
7.	8/2-(vi)	Two representatives of the district branch of the Bengal Library Association to be nominated by the Executive Committee of the said organization.

8.	8/2-(vii)	One person to be nominated by Sabhadhipati from amongst the members of Zilla Parishad of the Birbhum.
9.	8/2-(viii)	Following two persons are nominated by the Govt. from amongst the members of the Panchayat Samities in the district of Birbhum : (i) Sri Sovan Chowdhury, Member, Labpur Panchayet Samity, Vill. + P.O. – Labpur, Dist.- Birbhum. (ii) Sri Babulal Hansda, Member, Bolpur Sriniketan Panchayet Samity, P.O.- Sriniketan, Dist.- Birbhum.
10.	8/2-(ix)	Following two persons are nominated by the Govt. from amongst the members of the Managing Committees of Public Libraries: (i) Sri Sudip Mondal, Joint Secretary, Sidhu Kanu Pathagar, Old Circuit House, P.O.- Suri, Dist.- Birbhum. (ii) Sri Subrata Bhattacharjee, Secretary, Nanoor Rural Library, Vill. + P.O.- Nanoor, Dist.- Birbhum.
11.	8/2-(ix-a)	Following four persons representing the interest of education, social work, Cultural, literacy or artistic activity, or literacy or science movement are nominated by the Government in the district of Birbhum. (i) Sri Pranab Dutta, Bolpur Town Library, Sriniketan Road, P.O.- Bolpur, Dist.- Birbhum. (ii) Sri Ohidul Alam, M.N.K. Road, P.O.- Rampurhat, Dist.- Birbhum. (iii) Sri Sukumar Mukherjee, Vill. + P.O. – Chakpara, Dist.- Birbhum. (iv) Sri Koushik Ghosh, Nichupatty, P.O.- Bolpur, Dist.- Birbhum.
12.	8/2-(xiii)	Following two M.L.A.s of Birbhum district are nominated by the Government : (i) Sri Monirul Islam, Hon'ble MLA, Labpur Constitutency, Nutanpukur, Bolpur, Dist.- Birbhum. (ii) Sri Gadadhar Hazra, Hon'ble MLA, Nanoor Constitutency, Vill. + P.O.- Nanoor, Dist.- Birbhum.
