NOTIFICATION

The member of the Local Library Authority of every district in West Bengal are nominated/appointed/elected under different clauses of Sub section (2) of Section 8 of the West Bengal Public Libraries Act, 1979(As amended from time to time).

Except the members under clauses (i), (ii), (iii)&(iii a) of Sub-section (2) of section 8 of the West Bengal Public Libraries Act, 1979 (As amended from time to time) who are the members of the LLA by virtue of their ex-officio status in their posts and except the members under Clauses (iv),(vi),(vii) of the aforesaid section who are elected and nominated as per provisions of the said Act, the members of other clauses of sub-section 2 of section 8 are nominated or appointed in terms of Government orders issued by Mass Education Extension and Library Services Department.

Under sub-section (3) of Section 8 of the West Bengal Public Libraries Act, 1979 (As Amended from time to time), the members, other than ex-officio members shall hold office for a period of 4 years or till the Local Library Authority is reconstituted whichever is earlier.

Now, in exercise of the power conferred by sub-section (1) & (2) of Section 8 read with sub-section (3) of Section 8 of the said Act the Governor is pleased to reconstitute the Local Library Authority, Dakshin Dinajpur with the following members under different clauses of sub-section (2) of section 8 of the West Bengal Public Libraries Act,1979 (As amended time to time):

Dakshin Dinajpur, PIN – 733101. (ii) Sri Biplab Sen, Councillor, Word No. 8, Gangarampur Municipality, Indranarayan Cololony, P.O.- Gangrampur, Dist.- Dakshin Dinajpur, PIN- 733124.
7.	8/2-(vi)	Two representatives of the district branch of the Bengal Library Association to be nominated by the Executive Committee of the said organization.

8.	8/2-(vii)	One person to be nominated by Sabhadhipati from amongst the members of Zilla Parishad of the Dakshin Dinajpur.
9.	8/2-(viii)	Following two persons are nominated by the Govt. from amongst the members of the Panchayat Samities in the district of Dakshin Dinajpur. (i) Sri Tajmul Haque, Member, Harirampur Panchayet Samity, Vill. & P.O. Harirampur, Dist. Dakshin Dinajpur. (ii) Sri Rafikul Islam, Sabhapati, Banshihari Panchayet Samity, P.O. Buniadpur, Dist.
